The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of the following Government Officials to study Master's Programme in Environmental Engineering and Sustainable Infrastructure at KTH Royal Institute of Technology and Water Resources Engineering at Lund University during 10 August 2017 to 30 June 2019 or 2 (two) years from the date of commencement:

- (a) Mr. Md Didarul Alam Tushar, Executive Engineer (c.c.), Department of Public Health Engineering, Dhaka.
- (b) Mr. Md Mostafizur Rahman, Executive Engineer (c.c.), Department of Public Health Engineering, Dhaka.

(2) The terms & conditions are as follows:

- a) The period to be spent for the course, including transit, will be treated as on duty;
- b) They will draw their usual pay and allowances from Bangladesh in local currency;
- c) All expenses shall be borne by the Swedish Government.
- d) They will not be allowed to extend their stay abroad beyond this period;
- e) On return from Sweden they will report to their office and submit a study report individually along with Master's Certificate to the Local Government Division within 15 days.

(3) This order is issued with the approval of the competent authority.
