Sub: Governments sanction for participating Physical Inspection and Performance Test to be held in Switzerland.



- (c) They will draw their usual pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- (d) They will not be allowed to stay abroad beyond the approved period.
